Through the work of the Holy Spirit, we have seen over 300 victories in Christ. There should be of this number 25 to answer the call to the ministry and mission field. From this number, a choice young man and his wife are now preaching at Corinth Methodist Church in Knoxville, Tenn. I was with them in a meeting in Sept.
