Dear Families,

On December 1, 2025, the St. John Preschool and After School Ministry Team approved the preschool budget, registration, and tuition fees for the 2026-2027 school year. In determining the budget for next year, staff compensation was given high priority. We believe acquiring and retaining an excellent staff has made our preschool successful.

Please see the attached information sheet for the 2026-2027 fees. St. John Preschool is a non-profit organization and has been self-supporting since our second year of operation. The increase in tuition fees will enable us to increase our staff base compensation. Registration fees have increased by \$5 to reflect the increased expense of daily supplies. Early care and extended day program fees will not be increased. We remain at the lower end of tuition rates, student/staff ratio, and offer more special area classes without an additional fee in comparison with east-end preschools. Budget and price comparison information is available in the preschool office upon request. As always, we are willing to work with families regarding tuition. Scholarships (based on financial need) are available, and applications are in the preschool office. Please let me know if you would like more information.

- **Provide our community an excellent Christian preschool program which is child-centered and offers developmentally appropriate opportunities for young children.**
- **Hire and retain an outstanding team of loving Christian teachers, assistants, and administrators.**

- **Offer a premium preschool program at a fair and affordable cost to all people.**

The toddler programs are organized play groups incorporating age-appropriate skills and activities.

Optional Program: Extended Day Program (Noon-2:00) is available on Tuesday, Wednesday, and Thursday. The fee is \$16.00 per day (\$15.00 if paid quarterly/annually). Academic Extended Day is available on Wednesdays for four-year-old classes and Junior Kindergarten. The fee is \$20.00 per day.

Dates and Times of Operation: Projected start date is the last Monday in August and end date will be mid-May 2027.

Preschool is in session Monday-Thursday from either 8:45-11:45 am or 9:00am – 12:00pm depending on the class.
