President's Message

Tax Increases, Election of Officers and Short-Term Rental Ordinance

RHCA will have a lot to talk about at its Tuesday, April 24th meeting at 7 p.m. in the cafeteria at Rose Hill Elementary School. The County is proposing a real estate tax increase, an increase in the sewer as well as finalizing an assessment on real estate. The latter also could increase your tax bill. Also, scheduled for public hearing is an ordinance regulating short-term rentals. We talked about the proposed tax increase and assessments in last month's Rambler. The sewer tax increase and short-term rental proposals are discussed below. If you want to have a voice in any of these issues, you need to attend the April 24 meeting. As usual, refreshments will be served after the business portion of the meeting.

Before you read any farther, the officers and I want to thank all of you who already have joined RHCA for 2018. Without you, there would be no RHCA and no collective community voice that speaks to the County and state. Having said that, we are greatly concerned that such a small percentage of residents are not members of our Association. There are almost 750 homes in Rose Hill, with more on the way. At present, only about 20 percent are members of RHCA. I would be embarrassed if asked how many homes we really represent!

We were able to hear a presentation from the proposed development on Rock-A-By Lane, but the rest of the agenda was cancelled.

Postponed from the March meeting was our annual election of officers. For too long, the position of secretary has been vacant. We need someone to step up to assume that role to help keep our members informed of activities at our meeting. All the Ramblers are included on our web site, but there is no place for one to get a short rundown of RHCA activities. We would like someone to provide a monthly short update for The Rambler and help maintain our web site, myrosehill.com, in a timely fashion.

Of course, any of the present officers will be happy to step aside should anyone wish to replace them. Unfortunately, we all found out too late there are no term limits. However, we look forward to working with those persons who are willing to take over.

Finally, we still need someone to deliver The Rambler on Rose Hill Drive from Leewood Drive to Franconia Road, Eastchester Circle, Greenhaven Place, and the few houses on Franconia Road from Rose Hill Drive to Leewood Drive. It's a total of 26 houses. Several of our current volunteers are willing to fill the void, but we would rather not add to anyone route.

Sewer Rate Increase

A gradually increasing sewer service charge will take place on July 1 if the Board of Supervisors adopts the proposed hike as part of setting the new tax rate next month. The sewer charge rate per thousand gallons will go up 25 cents to \$7.00 starting July 1. Subsequent yearly raises on July 1 of the three additional years will raise the rate to \$7.34, \$7.70 and \$8.08. The current rate is \$6.75. The sewer-availability charge also would rise steadily to help pay for improvements at pollution control plants. The latter charge is for new homes only. Sewer charges are included in your bill from Fairfax Water and make up the largest amount of the balance due. It might be a good idea to have your home checked for leaky faucets, toilets, etc., as the drips add up both in water and what goes straight down the drain.

Short-Term Rental Housing

Fairfax County has scheduled public hearings on proposed public hearings for zoning rules covering short-term rentals. Hearings are set before the Planning Commission on Thursday, May 3 at 7:30 p.m. and the Board of Supervisors Tuesday, June 19 at 4 p.m. The County has been working on the new rules following adoption of a 2017 Virginia law that allows local governments to regulate short-term uses. Virginia law requires state approval for new local ordinances of this type.

Except for bed and breakfasts and hotels, short-term rentals are not allowed under Fairfax County law. At present, however, there are 1,500 active Airbnb listings in the County. Short-term rentals are defined as being those of 30 days or less. The proposed rules attempt to strike a balance between allowing short-term rentals and addressing neighborhood concerns.

Make no mistake about it, rental properties, both long and short term, are a problem in Rose Hill. Long-term rentals by absentee landlords can lead to deteriorating properties, overcrowding and lack of respect for the neighbors and the community. Short-term rentals can produce the same issues despite the presence of an owner. It will be interesting to see just how the County plans to deal with those problems under any new law.

The zoning ordinance in effect for communities such as Rose Hill limits the number of unrelated adults at each residence to four. The proposed ordinance would allow six short-term renters. It would allow homeowners to offer their primary residence as short-term lodgings but would not allow rentals for events or commercial purposes such as parties, weddings or fundraisers. It also would limit the number of days short-term lodging would be allowed. Officials are recommending a 90-night limit per year. Property owners could be required to be present when their property is used for short-term lodging.

This is an issue which should be of extreme interest to homeowners in Rose Hill. We have problems under the present rules that affect the property rights and values for everyone. One of the big questions is how the County plans to enforce the new rules, which will require payment of the transient occupancy taxes and get a permit for each operation. The tax currently is four (4) percent, half of which goes to the state to support tourism and regional transportation. That's on top of the six (6) percent sales tax.

Please come to the April meeting and join the discussion on this issue. RHCA needs to be heard on this issue, so we will be looking for members willing to attend the public hearings and speak up on our behalf. We need to guard against the adoption of any new rule that will cause further harm to our community. We have problems today that we are trying to manage within the existing law. Your community and property values are at stake.

Local Thespians Set Shows

Both the Edison High School Theater Program and the Rose Hill Elementary School Players are planning programs in the coming weeks. The Edison group will perform Rodgers & Hammerstein's classic "Fairy Tale Musical" in six shows starting April 27. The Rose Hill Players will be on stage with "Pirates of the Curry Bean" three times May 11 and 12. All performances will be at the Edison High School auditorium.

The Edison performances are schedule: Friday April 27, at 7 p.m. Saturday, April 28, 2 p.m. and 4 p.m. Thursday, May 3, 7 p.m. Saturday, May 5, 2 p.m. and 7 p.m. Tickets are \$5 for students and senior citizens, \$10 for adult general admission. Group rates are available. *The actual title of the show can't be announced in advance because of licensing restrictions, but it's the one with the Fairy godmother and the Glass Slipper.*

The Rose Hill Players take to the Edison stage on Friday, May 11 at 7 p.m. and Saturday, May 12 at 2 p.m. and 7 p.m. Tickets are \$7 for adults, \$5 for children with a special \$1 price for children at the Saturday matinee.

The Rose Hill Players will swashbuckler their way through a pirate adventure on the high seas in a musical designed to have you dancing in the aisles! It's about twins who find a treasure map and then have it stolen by Redbeard and his Pirates of the Curry Bean. The search for the treasure chest adds up to a voyage of adventure unfolding right before your eyes.

Here a good chance to support our local aspiring actors and actresses at an affordable price and free parking.

The exhibition, "Here, Now," features Tisara's new nature-themed work. For the last ten years she has focused on creating mosaics of unglazed porcelain. Tisara also is the founder of Living Legends of Alexandria, a nonprofit with a mission of identifying, chronicling, and honoring those who have made extraordinary contributions to the quality of life in the City of Alexandria. She also operates Tisara Photography on King Street in Old Towne Alexandria.

Driver's License ID Update

Last month's article about the new driver's licenses may have left the impression that everyone needs to rush out and renew so their license will comply with a new rule concerning air travel. As of 2018, all newly issued Virginia licenses will comply with the Real ID program that will be enforced by the Department of Homeland Security.

Enforcement begins in 2020. Virginia DMV says it will send you a letter reminding you to renew early. In my case, my renewal date is 2019, so I should be OK, assuming I can pass the test! If you have any questions, contact DMV at https://www.dmv.virginia.gov/drivers/#real_faqs.asp.
