President's Message

Changes to John Marshall Library Subject of January 24th Meeting

The Fairfax County Library System is planning major changes at our John Marshall Branch that will keep the building closed for some time beginning this spring. Representatives of the Library will present the renovation and schedule plans at the January 24 meeting of the Rose Hill Civic Association. The meeting begins at 7 p.m. in the community room of the library. The library presentation will begin shortly after 7 p.m. Included in the renovation is a building addition of approximately 1,400 square feet, more space at the front entrance and a new meeting room where the court yard is now located.

A roll down security grill will be installed in the lobby that will allow after hours use of the meeting rooms and the restrooms. Currently meetings must end when the library closes at 9 p.m. Access to the space when there are no meetings ongoing will be a community concern. Since RHCA will have to find another meeting spot while the changes are being made at the library, length of the closure will be important. RHCA has meeting scheduled in March, April, May and June before its summer hiatus in July and August. Some meetings this spring may have to be canceled if there is no alternative location.

Additional space within the library itself will be used for copiers, desktop computers, printers and study space.

NOISE COMPLAINTS

Residents are reminded that Fairfax County has a law that prohibits making noise that can be plainly heard in another person's home with the doors and windows closed between 10 p.m. and 7 a.m. Sunday through Thursday and between 11 p.m. on Fridays Saturdays and the day before a Federal holiday. Noise above 55 decibels is prohibited outside during those hours. There also are laws on the books for excessive daytime noise. These laws apply to Rose Hill and residential areas. Several recent cases have reported, resulting in this notice. If you have a complaint about noise, during daytime hours* call the Department of Code Compliance at 703-324-1300. At night and on weekends call the Police Department's non-emergency number, 703-691-2131. The TTY for both is 711. To enforce the law, the County may seek civil penalties against violators, as well as court orders to prohibit current and future noise. Penalties start at \$250.00, rising to \$500.00 for subsequent offenses. Please respect your neighbors' privacy and peace of mind. *Monday-Thursday 8 a.m. to 4 p.m. Friday 9:30 a.m. to 4 p.m.

The renovation also will allow for a reorganization of existing space for better efficiency, accommodation of new technology and library programs, according to the system's statement of justification. The requirements for the proposed use are on page 8.

The existing library opened in 1975 and has been renovated twice. The heating and air conditioning system was improved in 1987 and changes were made to comply with accessibility requirements in 1989. The library was a priority in the early days of the Rose Hill and surrounding communities. You can read the history of the facility at myrosehill.com. Click on the library mention in the upper left hand corner of the web page.

After the presentation, there will be a questions and answer period for both the library changes and other community issues. Refreshments will be served at the conclusion of the business portion of the program.

Paper, Not Plastic

The Fairfax County Board of Supervisors will hold a public hearing on a proposed ordinance amendment to ban plastic bags for the collection of yard waste and devices containing cathode ray tubes (CRTs) beginning July 1, 2017. This means that next fall you will have to use paper bags instead of plastic when you place leaves at the curb for county pickup. The hearing is scheduled for 4 p.m., Tuesday, January 24, 2017. Since RHCA doesn't meet until later that night, we will advance no community adopted position on this proposed ordinance. However, since the organized proponents will no doubt be out in force, it would be good for the Board to hear from some single-family homeowners with trees that shed leaves seasonally. Contact Lee District Supervisor Jeff McKay's office at 703-971-6162 or leedist@fairfaxcounty.gov and I am sure your voice will be heard. If the ordinance passes, you will have to buy paper leaf bags next fall. And, while we are on the subject, it is illegal to blow leaves into the street where they will clog the storm drain system and cause water ponding into the travel lanes.

The list of properties honored for lighting displays during

the holidays is included on Page 10. There were more lights this year in Rose Hill, therefore there are more properties listed. The categories are the opinions of the judges and neighbors who nominated specific addresses. If you have a property you think needs to be on the list, contact us and we'll mention it in the February Rambler. Some properties are missed because the lights weren't displayed at the time the judges made their rounds. If you disagree with some of the nominations, consider becoming a judge next year, at least for your immediate neighborhood. Residents also are reminded to make sure their house numbers are visible from the street at night. If it's hard to pick out house numbers for the holiday awards, imagine the time that could be lost in an emergency situation.

The Kroetches on Flower Lane and their nearby neighbors on Cottonwood Drive, the Campbells, had lights and displays made that little corner of Rose Hill a must see during the holidays. And the Grigsby's "Gingerbread House" on Willowood once again was a grand prize winner along with the Phillips, who are tucked away at the dead end of Maryview Street. Wayside Place in Rose Hill Reserve includes homes with long front stairs, many of which were strung with lights. Congratulations and thanks to all of those who cared enough to make Rose Hill stand out during the holiday season. There were hidden jewels everywhere, making a drive through the community especially pleasing during the season.

Follow the Budget

Defeat of the proposed "meals tax" in Fairfax County last November sets up another battle for your pocketbook this spring. The School Board already has asked for increased funds, and no doubt will spread the information that its budget historically has been cut. What they don't tell you is that the County has INCREASED the amount of money allocated to the schools in each of the last five years. The "cuts" are from the budget adopted by the School Board, which depends on the Board of Supervisors for annual allocations. The Board already has indicated that revenues this year will not be sufficient to meet the School Board's demands.

Schools receive more than 52 percent of the County budget. Here are the figures (in billions) over the last five years: 2012—\$1,774,305,286, 2013—\$1,848,079,349, 2014—\$1,889,380; 2015—\$1,945,639,569, 2016—\$2,012,310,822. And those figures don't include money for Head Start, School Health Nurses, School Crossing

Guards, etc., items that were included in the County budget and totaled more than \$60 million in Fiscal Year 2014.

Keep those numbers in mind when the School Board tells you it is facing cuts and programs will need to be curtailed. I agree teachers need a raise and suggest that the School Board make it a priority before they start funding the entire budget. The teachers should be at the top, not the bottom of the funding scale. I am skeptical of an organization that tells me they can't afford to adequately compensate its teachers within a \$2 BILLION-plus budget.

I spent five years on the Lee District budget committee and raised objections to annual school increases in the face of declining revenues while police, fire, parks, libraries and other county agencies were actually receiving less money than the year before. If the schools have their way, the tax rate on real estate (your house) will be raised this year in order to "fully fund" the school program. Pay attention as the process moves forward in the next few months.

Your comments are welcome in the Rambler or at our meetings.

Out of State Tags?

Fairfax County has a new program to make sure all owners of vehicles with out-of-state tags parked in the county pay their taxes, just like the rest of us. So far, more than 2,000 offenders have been identified, resulting in more than \$600,000 in tax revenue. You can help. If you see a car parked in Rose Hill that has out-of-state tags, you can report it anonymously. Please remember that some military personnel are exempt from the local law dealing with auto registration and taxes.

Report potential offenders to Fairfaxcounty.gov/dta/taxevasion/addrecord.aspx. You also can check on the status of previously reported out-of-state vehicles by substituting [checkstatus.aspx](http://Fairfaxcounty.gov/dta/taxevasion/checkstatus.aspx) for [addrecord.aspx](http://Fairfaxcounty.gov/dta/taxevasion/addrecord.aspx). In addition to the Virginia car tax, Fairfax County collects \$33 per vehicle on those parked or garaged in the county. Let's make sure everyone pays their share! Maybe if everyone does, maybe we can avoid a real estate tax increase this year!

Civil War Tour in April

The Franconia Museum will present its Eighteenth Both Sides Tour on Saturday, April 8, 2017. It is part of a twice-early series of Civil War tours that help raise funds for the Museum. This spring, the tour will focus on the activity in the Shenandoah Valley in 1864. Stops are planned at the site of Third Battle of Winchester, Fisher's Hill near Strasburg and Cedar Creek near Middletown. The Cedar Creek stop includes the viewing of an electric map that explains the locations of both North and South forces during the battle. Another stop in Winchester will be at the gravesite of Confederate Colonel George Patton, grandfather of the famous World War II general by the same name. Colonel Patton was killed at Winchester and is buried with his brother, who died a year earlier as part of Pickett's Charge at Gettysburg. The all-day tour leaves the Franconia Museum, 6121 Franconia Road, at 8:15 a.m. sharp on April 8. Included is a lunch stop at the Golden Corral all-you-can-eat restaurant in Winchester and a snack stop at McDonald's on the way home. The motor coach returns to Franconia at approximately 6:30 p.m. Cost is \$100 per person and includes a seat on the bus, lunch, snacks and all fees. Part II: Statement of Justification

Page 2

B. REQUIREMENT FOR PROPOSED USE:

• Why the new or expanded facility is needed:

Opened in 1975, the John Marshall Library has been renovated two times to improve the HVAC system in 1987 and comply with accessibility requirements in 1989. The original 1975 was designed to have the collection in two separate areas with the administration area located in the middle. The split collection layout is a major concern for the library staff since it is difficult to visually supervise the entire library. The existing public meeting room is only used during library hours as the staff is unable to maintain security separation for after-hour operations between the meeting rooms and the main library. There is no separate room for quiet study room since it is an open area adjacent to the collection area. There is no group study room which is standard to Fairfax County libraries.

Additional space is needed for copiers, desk top computers, printers, and study space for community use. A renovated facility will allow for a reorganization of existing spaces for better efficiency, accommodate new technologies and an updated library program use. A roll-down security grille in the lobby will be installed to allow after-hours uses of meeting rooms and restrooms. The Fairfax County Comprehensive Plan has identified the John Marshall Library for expansion based on the current library use trends.

The John Marshall Library project was included as part of the Fall FY 2012 Library Bond Referendum. The balance of the funding was approved at the FY 2014 Third Quarter Review. The feasibility study for this project was completed in December 2012 recommending a building addition of approximately 900 SF to meet the current program requirements of Fairfax County Library. However, due to a lack of sufficient meeting places within the community, Supervisor McKay of the Lee District requested an additional meeting room for this project. Additional 500 SF for a meeting room and supporting spaces is proposed for a total building addition of approximately 1,400 SF.

• Why the proposed location is the best location for the proposed use:

The library is an existing facility that will be renovated and expanded in place. No other locations were reviewed for this facility since the current location is central to the residential area which it serves. The proximity to Rose Hill Elementary school provides opportunity for the public to easily access the library.

• Why the proposed location and type of facility is the least disruptive alternative:

The site is located in the proximity to the Rose Hill Elementary School, and Rose Hill Shopping Center. The location is central to the core users within the area and travel time to this location is minimal. Access will be provided to and from the site at the current entrance location on Rose Hill Drive.
