## President's Message

### RHCA Members Get to Vote on Rose Hill Drive Bike Lanes

Members of the Rose Hill Civic Association will have the opportunity to vote on the proposed restriping of Rose Hill Drive to include bike lanes. The layout for the proposed bike lanes is included in this issue of The Rambler. The vote will take place at the RHCA meeting on Tuesday, March 28 at the John Marshall Library. Voting will take place between 6:30 p.m. and 8 p.m. Members can obtain ballots at the meeting and make their choice. The totals will be announced soon after 8 p.m. The vote will NOT affect the repaving of Rose Hill Drive, only the proposal to add bike lanes.

If you are not a member of RHCA, you can join at the meeting by filling out a membership form and paying the fee. If you already are a member, your name should be on the list printed on pages 6 and 7. Please be aware that if you mailed your application form within the past week, your name will not be on the printed list but will be recorded on the list available at the meeting.

During the voting, other RHCA business, including the annual election, will take place. Information about the County budget and proposed development on the Rock-A-Bye Road property will be discussed. Information on both subjects is available in this newsletter.

#### SPRING CLEANUP

*In an effort to maintain Rose Hill as an attractive and safe community in which to live, RHCA suggests that residents take a look at their and surroundings properties to see if any improvements need to be made or reported. Please report trash piles, illegal or inoperative vehicles, excessive parking in the front yard and overcrowding to the proper County authorities. Trash, overcrowding and illegal front-yard parking should be reported to Zoning Enforcement at 703-324-1300. Illegal or inoperative cars on the street should be reported to the police non-emergency number at 703-691-2131. Rose Hill is part of a residential parking zone, so boats, trailers, etc., are not allowed to park on our narrow streets. Only one commercial vehicle is allowed per property and must be owned by the resident. Illegal or inoperative vehicles parked on private property should be reported to the police traffic division impound section at 703-280-0587. Vehicles without valid tags or inspection stickers are illegal on private property.*

Refreshments will be provided at the conclusion of the voting and business meeting.

#### Proposed Development

Fairfax County accepted a plan March 15, 2017 for a new subdivision of 16 single family dwellings called Rose Hill Meadow. It is located off Rock-A-Bye Road and bordered by houses on Lark Lane, Sturbridge Court, Rose Hill Drive, Bee Street, Willowood Lane and Telegraph Road. The property is zoned R-3, the same as the rest of Rose Hill. Since the property already is zoned, there will not be a public

hearing. RHCA will monitor the progress of the plan to make sure that all County laws and zoning rules are followed. We will post a copy of the plan on our web site, [myrosehill.com](http://myrosehill.com), as soon as one is obtained electronically. We hope to have a copy of the plan available at our March 28 meeting. The owner is listed as Eastwood Properties, INC., 3050 Chain Bridge Road, Suite 103, Fairfax, Virginia, 22030. The owner is listed as Richard Labbe of the same address. An outline of the area that is the subject of the plan is included on page 9. The information in this issue of The Rambler reflects what was available on March 20, 2017. Additional information will be made available as it is received.

### **Election of Officers**

We also will hold our annual election at the March meeting, as prescribed in the Bylaws. At the least, we need to fill the vacant secretary's position. Members are encouraged to run for any of the Association offices. The current officer holders will gladly yield to new blood and pledge to make a smooth transition. If you would like to see Rose Hill continue to be a safe, convenient and comfortable place in which to live, please get involved. It takes diligence on our part to make sure Fairfax County zoning rules and other ordinances are followed in order to maintain our property values. Nothing detracts from a community more than a rundown property and illegal inactivity. It takes all of us, not just the neighbors, to make sure the County is aware of violations enforces its laws. Without our diligence, we will be overrun with illegal activity and our property values will plummet. Not a pleasant thought if you want to sell or leave property to your heirs. To be sure, operation of RHCA means work for a few, but all members share in the rewards. If you haven't already done so, join RHCA for 2017.

### **2017 Tax Information**

While the Board of Supervisors has voted to maintain the property tax rate at \$1.13 per \$100 of assessed value, expect your taxes to go up if the value of your property has been increased over last year. The assessment notice you received in February will tell the story. And, while the tax rate has not been increased, the Board retains the ability to increase charges such as water and sewer. So, we won't know the full impact until the entire fiscal year 2018 budget is enacted in May and becomes effective July 1. The proposed budget of money from county sources is \$4.10 Billion. The total budget of \$7.99 Billion to be appropriated includes Federal and State grants. Of

the \$4.10 billion in County funds, 52.8 percent or \$2.17 billion will be spent on schools. That is a \$51.69 million increase over last year. Remember that increase when the School Board claims that it is being underfunded. And that figure doesn't include an additional 83.4 million the County provides for programs such as Head Start, school health, school resource officers, school crossing guards, behavioral health, after school and recreational programming. The School Board annually produces a budget that is in excess of what the County deems affordable. The proposed county increase this year comes from the increased value of real estate.

### **Tax Calculator**

For the first time, you can find out exactly how much of your tax dollars are spent on the services the county provides. Go to [fairfaxcounty.gov/taxcalculator](http://fairfaxcounty.gov/taxcalculator) and enter your address and tax assessment. The assessment information is easily obtained though the same web address. For example, I learned that 52.7 percent of my taxes, or \$2,274, went to schools. Public safety received 11.8 percent, or \$509.35. Parks and libraries received a paltry 1.3 percent, or \$56.11. I constantly hear from residents and those who attend RHCA meetings that public safety is the community's No. 1 priority. Not reflected in those numbers! I'm sure you will find the same type of information in your tax rundown. The only time we have a say in how our tax money is allocated, is at budget hearings. If you, like me, feel public safety, as well as our parks and libraries, are being shortchanged, let the Board of Supervisors know. An old-fashioned written letter, I find, is the best way, because they can't delete it as easily. If you have questions about the tax calculator, we'll discuss it in more depth at the March meeting. It certainly is an eye opener.

### **No Meeting in April**

RHCA will not meet in April because of the closing of the library for renovation on April 15. Publication of the April Rambler will depend on the amount of news. We hope to resume meeting and publication of the Rambler in May, depending on a volunteer to serve as scheduler for potential sites. 

Hi! This month I'd like to talk with you about Private Mortgage Insurance, aka PMI. When you bought your home and provided less than a 20 percent down payment, you probably had to buy PMI, which was added to your monthly loan payment. Did you know that once you have made enough payments to create at least **20% equity** in the home (based on the original appraised value of the home) that you can **stop paying PMI**? When you closed on your home, the lender was required by law to tell you how many years and months it will take to reach that 20% equity, assuming you did not pay any additional principal on the loan. If you miss that mark and the **equity increases to 22%, the lender/mortgage servicer is required to cancel the PMI**. Save yourself some money and check your original settlement documents to ensure you aren't paying one penny more than necessary on PMI. Note, however, that if your loan was insured by the Federal Housing Administration, was originated sometime after mid-2013 and your down payment was less than 10%, you may have to pay PMI for the life of the loan.
