## 2026 SLATE

At the Annual Members' Meeting on March 1, 2026, voting will be held to approve the slate of nominees as presented to the church body by the Council and the Nominations Committee which includes all the new Council members as well as the individuals being recommended to fill the seats that are vacated in the Nominations Committee.

The Nominations Committee, being tasked with recommending to Council new members who would replace the outgoing Council members, had sent bulletins via email blast to the members, had made announcements in the Worship Services, and posted the Nominations invite video on the UCM website and other digital platforms for the past year, to solicit from the congregation names of people who they would feel would serve well in leadership in UCM.

Those who were willing for their names to be considered for nominations have been pre-qualified to match their church service experience, work background, and spiritual maturity with that of the position that will be vacant. They have undergone the proper nominations process and have been prayerfully considered. Thus, nominations are no longer accepted from the floor of the UCM Annual Members' Meeting.

The nominations procedures and election/selection/affirmation of nominees are all based on the UCM By-Laws Article IX. The guiding verses for the nominations process are found in *1 Timothy 3:13-31*, *Titus 1:6-8*, and *Matthew 20:25-28*. The election/affirmation of nominees is by the simple majority of votes.

**William Alcantara** (Property)

Now on the 2nd year of his term on Council, William is an energy efficiency professional/ entrepreneur and is the Managing Director of Vega Energy Services. He earned a Master's degree in Energy Efficiency and Climate Change from the Universidad Complutense de Madrid. William and his wife, Thania, have been members of UCM since 2015 and have both been involved in various ministries

within UCM. At one season of his life, William was a Youth Pastor, a Missions Team Leader, and the National Director for Ministry Partnership Development at Victory Church, BGC. He has been a member of the UCM Property Committee for the past 3 years.



**Ephraim "Ep" T. Brion** (Discipleship)

Now on the 3rd year of his term on Council, Ep is a Filipino-American who has over 45 years of experience in various ministries and has been a church planter, denominational national youth minister, seminary professor, pastor of several churches, a pastor care minister, an equipper, and a ministry coach. In 2002, Ep was called to the United States where he became the lead pastor of San Diego Christian Fellowship, a multi-congregation, multi-cultural

church in San Diego, California. After 8 years of service, Ep was led back to the Philippines to strengthen and equip fellow believers through various discipleship programs, leading him and wife, Lulu to establish GraceNet Philippines. Ep was first connected to UCM in 2018 and has served as a Senior Advisor and Equipper/Coach under the Discipleship Committee. Outside of UCM, Ep and Lulu continue to coach 14 pastor couples and disciple individual believers.

**\*Justin Sucgang** (Corporate Secretary)

Justin is an Associate Professor of the De La Salle University Tañada-Diokno School of Law and the Vice-President of the Law Professors' Association of the Philippines. He recently completed his Doctor of Juridical Sciences at Fordham University School of Law, and earned his Master of Laws from the University of Michigan Law School on a Fulbright scholarship. Before joining the legal academy full-time, Justin worked under the Office of the

President of the Philippines across two administrations. There he rose through the ranks, having started as Technical Assistant until he became a Director. One of the youngest presidential appointees, Justin served as Commissioner to the Legal Education Board prior to his stint in OP.

Justin and wife, Gertrude, were regular attendees of Redeemer Presbyterian Downtown Church in New York City and active members of its Sunday Service (Ushering) Team. The Spirit led them back to the Philippines and, after prayerfully asking for a spiritual home where they could mature as Christians, to UCM. # REPLACEMENT NOMINEE FOR 2026 COUNCIL

*Amended By-Laws of UCMI (ratified 17 Feb 2013):*

## **ARTICLE III COUNCIL**

**SECTION 3.5 Vacancy.** *In case of a vacancy in the Council by reason of a candidate not receiving a majority of votes cast during an election, death, resignation, disqualification or other causes, the remaining members of Council, if still constituting a quorum, shall select a replacement from the nominees recommended by the Nominations Committee (composed of former Council members who have served faithfully). Said replacement nominees, who have agreed to be available to serve on Council for the upcoming Council term year, shall be listed on the bottom of the ballot for Council, for the information of the voting membership. Otherwise, a special members' meeting shall be called by the remaining members of Council to fill the vacancy. A person chosen to fill the vacancy shall serve only for the unexpired portion of the term. However, he or she shall be eligible for re-election to the same office in succeeding elections for not more than three (3) full consecutive terms. (as amended by the Board of Trustees on 17 January 2013 and ratified by the Members on 17 February 2013)*

### **Grace Shangkuan Koo**

Grace is a retired Full Professor of Educational Psychology at the University of the Philippines (UP) where she taught for 25 years at the College of Education. She is a holder of four academic degrees, namely: Bachelor of Music, Master of Christian Studies, Master of Education in Educational Psychology, and Ph.D. in Educational Psychology. In 2003, she also took further post-doctoral studies in Mind, Brain and Education at Harvard University in Boston, USA.

Aside from UP, Grace has taught at De La Salle University, Asian Theological Seminary (ATS), Biblical Seminary of the Philippines (BSOP), International Graduate School of Leadership (IGSL), Asian Graduate School of Theology (AGST), and Philippine Association of Christian Education (PACE). A published author of 14 books, her latest in 2025 is titled, "Aging with Grace and Courage".

In her earlier years, she served as youth pastor, choir conductor, and Adult Sunday School teacher at United Evangelical Church of the Philippines. Later, she and her husband, Caleb, became UCM members in 2002. At UCM, Grace served as an elder and Chairperson of the Worship Committee in 2007-2009. She has also served as guest speaker, liturgist, Communion server, women's retreat speaker, Chancel Choir retreat speaker, Centennial Anniversary Committee member, instructor in Adult Christian Education courses, and participant in Chancel Choir special music events. She is also the co-founder of the Hymn and Oratorio Society of the Philippines (HYMNOS).

### **WeeChee Santos**

WeeChee is originally from Malaysia and has been worshipping in UCM for 30 years. She became a UCM member in 1996 and has actively participated in its numerous programs/events of the church. WeeChee has served in the Women's, Discipleship, Missions and Benevolence Ministries, and the Nominations Committee. She was in Council as Chair of Discipleship Ministry from 2005-2007.

# REPLACEMENT NOMINEE FOR NOMINATIONS COMMITTEE

*Amended By-Laws of UCMI (ratified 17 Feb 2013):*

## **ARTICLE IX NOMINATIONS COMMITTEE**

**SECTION 9.5** *Vacancy. In case of a vacancy in the Nominations Committee by reason of a candidate not receiving a majority of votes cast during an election, death, resignation, disqualification or other causes, the Nominations Committee shall select a replacement from the list of members who have served in the Nominations Committee (as per Section 9.3 above). Said replacement nominees, who have agreed to be available to serve on the Nominations Committee for the upcoming year, shall be listed on the bottom of the ballot for Nominations Committee, for the information of the voting membership. A person chosen to fill the vacancy shall serve only for the unexpired portion of the term. However, he or she shall be eligible for re-election to the same office in succeeding elections for not more than one term of three (3) years. (as amended by the Board of Trustees on 17 January 2013 and ratified by the Members on 17 February 2013)*

She is the Founder/Director of Shiphrah Birthing Home, President of HELP International Ministries, Inc. and serves as Adjunct Faculty in Community Development at Asia Pacific Nazarene Theological Seminary (APNTS).
