- Application, enrollment, and re-enrollment fees are **non-refundable**.
- **New student application fees** are submitted online at the time of application. Upon acceptance, students will be invited to complete enrollment forms, pay the enrollment fee, and set up a tuition payment plan through FACTS online.
- **Re-enrollment:** The student's account must be in good standing to re-enroll. All current students need to complete the online re-enrollment forms and finalize their tuition payment plan by 1/31/2025 to secure their '25-'26 placement.

Heritage Christian Academy tuition charges are by the academic year and determined annually by the HCA School Board. We do not prorate tuition for absences of any length due to any reason. We use FACTS Financial to collect tuition and fees. All enrolled families must select a payment plan through FACTS Financial. Once a payment plan is selected, tuition and fees are set to withdraw automatically. **The first tuition payment for the 2025-2026 school year will be due and withdrawn in the first ten days of June (6/1/25-6/10/25).** FACTS Financial will outline payment plan options.

**Full Payment Discount:** If you pay in full and your payment is processed by 6/10/2025, you will receive a 3% discount on tuition only.

**Withdrawal policy:** Parents/guardians must submit an official *Notice of Withdrawal* (available in the Main Office) to withdraw a student. All fees are nonrefundable. Tuition financial obligations are as follows:

- After May 1, 2025: Families are obligated to pay the first month of tuition.
- After June 10, 2025: Families are obligated to pay the first quarter of tuition.
- After August 31, 2025: If a student is withdrawn at any time during the school year, the tuition obligation runs through the end of the quarter of the official date of withdrawal.

**Additional fees** may be requested to help cover field trips as well as special class projects and/or supplies. Middle/high school electives may have associated fees and/or requests for supplies. **Additional/optional expenses** throughout the year may include but are not limited to before- and after-school extended care, Learning Success Center fees and services, lunch services, after-school clubs, athletics, school pictures, and yearbooks.

**New/transfer students:** We will prorate tuition for students who begin *after* the start of the academic year on a quarterly or monthly basis, depending on the time of enrollment and proximity to the start of a new quarter. If the student does not begin at the start of a new quarter, we will prorate tuition based on a monthly prorate (annual tuition will be prorated based on a 10-month academic year). Students who start on or after the 15<sup>th</sup> of the month will be charged one-half of the tuition payment for that month. If the student has four or fewer school days in the month he or she starts, tuition will be waived for that first month.

**Extended Care Fees:** Before and after school extended care is billed by the half hour (\$14 per hour for the 25-26 school year). Preschool and elementary students who are not picked up within 15 minutes of the end of the school day will automatically be placed in Extended Care, and extended care rates will apply back to the end of the instructional day. Any child not picked up by 6:00 p.m. from Extended Care will incur a late fee of \$1.00 per minute until picked up by a parent or other authorized person.

**Late payment fees:** A late fee may be assessed for past-due balances. Any late fee incurred will be shown on the next FACTS statement. If any late fees are returned, they will be included on the next statement. Fees are subject to change.

**Past due accounts:** Unless an arrangement for payment has been established, we reserve the right to cancel enrollment and withhold student records after 30 days of account delinquency. As the Bible commands, we desire to make every effort to live at peace and to resolve disputes with each other in private or within the Christian community in conformity with the Biblical injunctions of I Cor. 6:1-8, Matt. 5:23-24 and Matt. 18:15-20. We will approach any claim or dispute arising out of or related to our financial agreement with biblically-based mediation; however, in the event that all efforts for mediation are exhausted, we reserve the right to refer delinquent accounts to a collections agency.
