## Parent Contract:

I agree to pay the registration fee and supply fee listed when registered. I also agree to pay tuition 10 times for the school year program. I am aware that not paying fees on time will result in my child not being allowed to attend until fees are paid. I understand that I am responsible to pay the \$125 supply fee and \$150 registration fee before my child is considered registered for school. I understand fully that payments are due on the 10th of the month and are late after the 15th. I understand that as of the 15th I will receive a \$20 late charge (per child). I understand that my child will not be allowed to attend if payment becomes 30 days late and arrangements have not been made to rectify missed payment. I understand that tuition is based upon 10 months and is broken down into 10 equal payments. I understand that months shortened due to a holiday or weather are not prorated. I agree to provide a two week notice in writing if I withdraw my child from the program. I also understand that my child may not be withdrawn from the program after March 1. I understand that if anyone else needs to pick my child up notice before hand is required. All guests must knock on the door and bring a photo ID. It is my understanding that I am signing a 10 month (August-May) contract with Taylor Road Baptist Church Early Learning Center and must abide by the rules outlined in the above section. If I cannot fulfill the terms of this contract I will leave gracefully and with integrity remembering the primary purpose of this program is to minister to children. I understand that prices may need to change but a notification will be provided at least 60 days in advance of increase.
