Property & Finance Committee Report: M Miller & B Neben

Finance committee discussed funding Fr. Dan

Fr. Dan agreed to a voluntary pay reduction for the 2024 calendar year, and was inadvertently overpaid in the first months of the year

Finance committee recommends (1) ceasing all compensation to Fr. Dan after May 5 – the mandatory 90 period of the Title IV per the canons of the Diocese of Southern Ohio and (2) “clawing back” the overpayment noted above

For the period ending March 31:

The deficit is getting worse

Pledges are down

Open plate is up

Insurance and utilities are up

Irish Spring event on April 13 did not have proceeds

The rental property at #701 Far Hills Avenue has been vacated

Finance recommends increasing the rent for the rental property

Vestry agrees that the rent should be increased \$1800 and a new tenant obtained ASAP

A parishioner - purchased and installed a new garbage disposal in the main kitchen and the vestry is very grateful

Warden's Report: M Miller

Senior Warden is out of town

Had discussed a stewardship celebration on April 26, but that might be too soon to plan
Program year is coming to close on May 19, so maybe wait until after that
Maybe do a luncheon on Sunday June 2
Could be a joint newcomer and stewardship celebration
Might be helpful to form a vestry subcommittee to plan this
Need to schedule a meeting with the Bishop either before or after her visit on May 12
Meeting would be in the evening after 5pm
M Miller will reach out to the Bishop with our availability to see what works for her
The vergers are going to take a summer sabbatical
Dayton Yoga is going to close, so they will not need Room 12
Clerk will send out a draft of the minutes within one week of the meeting
Kate Furmanski, C Campbell, and K Walters will help with parish communication efforts,
including Subsplash, social media, etc.

Randy Young has agreed to serve the unexpired term of the Finance Committee chair.
