To oversee, to influence, and to make decisions that affect everyone


When did the Church lose its “HEAD”

in 1954 Churches were added to the IRC 501(c)(3)



Voluntary Compliance

- "voluntary" typically implies something done willingly or by choice
- "compliance" suggests adhering to rules or regulations.
- Churches can voluntarily offer the required information to contract with the government. However, once they've provided that information voluntarily, adherence to the terms of the contract becomes mandatory.



MANIPULATION

influencing or controlling someone or something to achieve a desired outcome, often in a sneaky or deceptive way

Church loses its authority and freedom

- Follow Rules: Churches need to follow IRS rules about how they run their activities and use their funds to keep their tax benefits.
- Report to IRS: Churches must report their financial information to the IRS each year, showing how they spend their money and handle donations.
- Stay Out of Politics: Churches can't support or oppose politicians if they want to keep their tax benefits.

BREAK THROUGH

Marbury vs Madison case, John Marshall declared the constitution is the supreme law of the land! This is Where the government had more power and thought to be above the constitution, However that was kicked out.



Supreme Court Turned To The Constitution

Whenever the congress would have a conflict with the constitution, the Supreme Court would turn to the constitution

Whats the big deal?

The Marbury v. Madison (1803) is a landmark U.S. Supreme Court case that established the principle of judicial review. The court ruled that it had the authority to review and potentially invalidate actions of the other branches of government if they were found to be unconstitutional. This case significantly strengthened the judiciary's role in interpreting the Constitution.

(C) EXCEPTIONS


(1) MANDATORY EXCEPTIONS

SUBSECTIONS (A) AND (B) SHALL NOT APPLY TO—

(A) CHURCHES, THEIR INTEGRATED AUXILIARIES, AND CONVENTIONS OR ASSOCIATIONS OF CHURCHES,

THE PRIVATE DOMAIN

A sanctuary, constitutional shelter, shield, and domain set apart and a preserve according to a number of U.S. Supreme Court decisions.

1. Churches and Ministries
2. Your personal and family life
3. Your God given businesses



HOW DO I GET A 508(C)(1)(A)

**508c1a is NOT an entity in and of itself.
508c1a is a section from the IRS.**



THERE IS 2 LAWFUL STRUCTURES



1. **Private Trust**
2. **Unincorporated Church**

PRIVATE TRUST

Own nothing control everything!



Personal

Removes you from reporting taxes to the IRS. allows you to allocate funds as you desire without restriction.

Family

Safeguards and protects your assets, real estate, vehicles and anything that has been entrusted to you by God

Business

Allows your business to operate privately without having to contract with the government. Which means your business does zero reporting to the IRS.

UNINCORPORATED CHURCH

Not corporated, Not asking permission to conduct activities, Not contracting with government as a business

- Constitutional
