ACTIVITY PARTICIPATION AGREEMENT

The Adult and Minor Participant(s) identified below hereby request to participate in the following:

Description of Activity: Zona Camp at California Baptist University

Activity Date(s): June 29 - July 3, 2026

In consideration of Common Ground Church's agreement to allow the Participant(s) identified below to participate in the Activity, the receipt and sufficiency of which consideration is hereby acknowledged, on behalf of themselves and the Minor Participant(s) identified below, and on behalf of each of their heirs, executors, administrators, successors, assigns, and personal representatives, the Adult Parent/Legal Guardian(s) identified below agree as follows:

Assumption of Risk: I understand that participation in the Activity, by its very nature, includes certain inherent risks, known and unknown, that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary, but I understand that they may include property damage, bodily injury, personal injury, emotional injury, death, financial injury, temporary or permanent disability, paralysis, risks associated with travel in a vehicle, and dangers associated with potential misjudgment or negligence of Church staff or other Activity participants. I further understand and acknowledge that participation in the activity creates an increased risk of coronavirus transmission. I understand and appreciate the risks that are inherent in the Activity and have had the opportunity to discuss them with a representative of the Church. To the fullest extent permitted by law, I agree to assume any and all risks of injury or harm that may be sustained by while or in connection with the Activity, including but not limited to the increased risk of Coronavirus transmission.

Acknowledgement of Safety Protocols: I agree to comply with all safety-related rules, regulations, guidelines, training, and instructions pertaining to the Activity. This includes but is not limited to the following additional coronavirus-related safety protocols, if required, like: Practicing six feet social distancing from other teams, washing hands regularly and wearing face masks when interacting in public places or businesses. I understand that, in its sole discretion, the Church may terminate participation at any time if any Participant does not comply with these requirements.

Waiver of Liability: I acknowledge and agree that I shall have no legal recourse against the Common Ground Church, and its affiliates, subsidiaries, divisions, Board of Elders, administrators, directors, officers, employees, agents, contractors, and volunteers (collectively the "Church") and all persons or entities having any ownership or possessory interest in the locations at which the Activity is hosted and their employees and agents (collectively the "Owner") for any injuries arising from or connected in any way with the Activity. I agree to hold the Church and the Owner completely harmless and not liable, and to release the Church and the Owner from all liability whatsoever, and agree not to sue the Church and the Owner, on account of or in connection with any claims, losses, demands causes of action, losses, costs, or expenses arising out of or connected in any way with participation in the Activity, *including but not limited to Coronavirus transmission*. This release is intended to discharge the Church and the Owner against any and all liability whatsoever arising out of or connected in any way with the Activity, including liability that occurs as a result of travel to and from the Activity, liability that occurs before, after, and during the Activity, liability that occurs either on or off Church-owned premises, and even though that liability may arise out of the negligence or carelessness on the part of the Church, the Owner, or others.

Indemnification: To the fullest extent permitted by law, I agree to immediately defend, indemnify, and hold the Church and the Owner harmless from and against all claims, demands, negligence, causes of action, suits, damages, costs, losses, expenses, judgments (including payment of attorney's fees, fines, penalties and other related costs and expenses), and liabilities of every kind and nature whatsoever, whether in law or equity, and regardless of whether the allegations are false, fraudulent, or groundless (collectively "Claims"), to the extent arising out of any Participants' participation in the Activity, including all attorney's fees and costs or other amounts incurred by the Church or the Owner for defending such Claims. The indemnity shall apply regardless of any active and/or passive negligent act or omission of the Church, the Owner, other responsible party, or their agents or employees.

Video/Photo Release: During the Activity, photographs may be taken, and videos may be produced and used for future publicity. I give permission for images of the Adult and Minor Participant(s) identified below, including but not limited to images captured by video, photo, and digital camera, to be used for the purposes of the Church, including in promotional materials and publications and agree to waive any rights of compensation or ownership thereto.

Authorization and Consent to Medical Treatment: By my signature below, I certify that the Participants' are medically fit to participate in the Activity. If any Participant is injured any time during the Activity, I hereby authorize and consent for the Church to administer general first aid treatment for any minor injuries or illnesses the Participant may experience. If the injury or illness is life threatening or in need of emergency treatment, I authorize the Church to summon any and all professional emergency personnel to attend, transport, and treat the Participant, and to issue consent for any X-ray, anesthetic, blood transfusion, medication, or other medical diagnosis, treatment, or hospital care deemed advisable by, and to be rendered under the general supervision of, any licensed physician, surgeon, dentist, hospital, or other medical professional or institution duly licensed in the State of California. I understand that this authorization and consent is given in advance of any specific diagnosis, treatment or hospital care which may become required, but is given to provide authority and power to the Church to render care in the best judgment of the Church upon the advice of any such medical, dental, or emergency personnel. I understand that efforts shall be made obtain the consent of the injured Participant (or their parent/guardian if the injured Participant is a minor) prior to rendering treatment, but that treatment will not be withheld if the injured Participant (or their parent/guardian if the injured Participant is a minor) is incapacitated, unavailable, or otherwise unable to provide consent. I further acknowledge and understand that the Church does not provide automobile, liability, or medical insurance coverage for any Participant in connection with the Activity. I acknowledge that the Participant(s) has/have their own automobile, liability, and medical insurance, and I agree to assume all responsibility for payment for any treatment the Participant(s) may receive.

Severability: I understand and agree that, if any provision of this Activity Participation Agreement or the application thereof is held invalid, the invalidity shall not affect other provisions or applications of this Agreement which can be given effect without the invalid provisions or applications. To this end, the provisions of this Agreement are declared severable.

Governing Law and Venue: This Activity Participation Agreement shall be construed in accordance with, and governed by, the laws of the State of Arizona. The venue for any action arising out of this Agreement shall be the County of Pima, State of Arizona.

Construction and Scope of Agreement: The language of all parts of this Activity Participation Agreement shall in all cases be construed as a whole, according to its fair meaning, and not strictly for or against any party. This agreement is the only, sole, entire, and complete agreement of the parties relating in any way to the subject matter hereof. No statements, promises, or representations have been made by any party to any other, or relied upon, and no consideration has been offered or promised, other than as may be expressly provided herein. This Activity Participation Agreement supersedes any earlier written or oral understandings or agreements between the parties.
